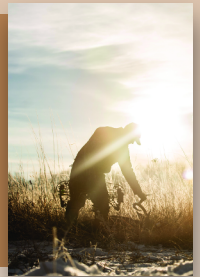

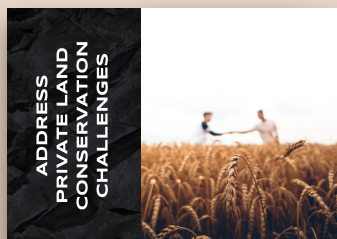
HOW IS THE SPORTSMEN'S HERITAGE FUND INVESTED?

The Sportsmen's Heritage Fund is an endowment managed to achieve maximum returns over the long-term consistent with prudent levels of risk and the objective that the real value (i.e., purchasing power) of all Endowment Funds shall be maintained and increased. A secondary long-term objective is to exceed the median performance of endowment funds managed by other non-profit organizations as measured by a comparable benchmark.

HOW ARE EARNINGS GENERATED THROUGH THE FUND USED?

When approved by the CSF Board of Directors, Sportsmen's Heritage Fund withdrawals are used to supplement CSF's existing sources of year-to-year revenue generated through corporate donations, annual gifts from individuals, grant support, and event revenue and will be used to:

- ▶ Ensure that CSF's ability to advance the mission is less susceptible to the ups and downs of the economy and the volatility of a rapidly changing world.
- ▶ Invest in enhancements and build capacity for existing programs including the Congressional Sportsmen's Caucus, National Assembly of Sportsmen's Caucuses and Governors Sportsmen's Caucus.
- ▶ Provide additional resources needed for sportsmen-driven policy campaigns and initiatives.
- ▶ Pursue strategic growth through state / federal program expansion and focus:



WHAT IS THE SPORTSMEN'S HERITAGE FUND SPENDING POLICY?

All net investment returns generated through charitable gifts will remain within the Sportsmen's Heritage Fund for investment with oversight from the CSF Board of Directors. In any year in which the combined value of the Endowment Funds exceeds \$5 million, the CSF Board of Directors will determine an appropriate percentage of the average value of the Sportsmen's Heritage Fund to be withdrawn and added to CSF's budget for next fiscal year. Until such time as the combined value of the Sportsmen's Heritage Funds shall exceed \$5 million, such percentage shall not exceed 2% of the Sportsmen's Heritage Fund.

HOW WILL MY GIFT TO THE SPORTSMEN'S HERITAGE FUND BENEFIT SPORTSMEN AND WOMEN?

Your legacy gift will represent a durable investment in CSF as the informed authority across outdoor issues and the primary conduit for influencing public policies that impact America's sportsmen and women in all 50 states. Our mission, paired with our education and advocacy-based programming, directly benefits sportsmen and women through tireless pursuit of our core values in the form of public policies impacting the outdoors:

DIPLOMACY – Effectively using knowledge, experience and relationships to advance the cause.
